Information clause in accordance with GDPR

We would like to inform you that:

- 1. The administrator of the data indicated in the consent to the processing of personal data expressed above is the Association "Forum Szkół Międzyarodowych" in Wrocław at ul. Drukarska 52. The purpose of collecting data is to implement the statutory tasks of the Association,
- 2. In connection with the processing of personal data by the Association, you have the right to:
- a) access to the content of data pursuant to Article 15 of the GDPR;
- b) rectification of data pursuant to Article 16 of the GDPR;
- c) deletion of data pursuant to Article 17 of the GDPR;
- d) restrictions on data processing pursuant to Article 18 of the GDPR;
- e) object to the processing of data pursuant to Article 21 of the GDPR;
- f) data transfer pursuant to Article 20 of the GDPR.
- 3. Expressing consent to the storage of data is voluntary, but necessary for the implementation of the statutory purposes. In the absence of consent, it will not be possible to accept as a member of the Association.
- 4. Giving consent to store and publish photos is voluntary. In the case of

If you do not give your consent, you undertake to ensure that you do not participate in photographic sessions during meetings organised by the Association.

- 5. Your personal data may be made available to other recipients or entrusted to other entities and institutions in order to achieve the statutory objectives of the Association.
- 6. The data controller will not transfer personal data to a third country or an international organisation.
- 7. The data provided by you will not be subject to profiling.
- 8. You have the right to withdraw your consent to the processing of your personal data at any time, without affecting the lawfulness of the processing carried out on the basis of consent before its withdrawal.
- 9. You have the right to lodge a complaint with the supervisory authority, i.e. the President of the Personal Data Protection Office.
- 10. Your personal data will be stored for the period of membership in the Association, and after the termination of membership, for the period necessary to settle the projects in which you participated as members of the Association and for the time necessary for the Association to fulfill its obligation to archive documents resulting from generally applicable national regulations.
